RESPONSE

Management Alert OIG Case: 20-0019-1

OFFICE OF THE COMPTROLLER 4-2-2020

This is in response to the Management Alert OIG Case: 20-0019-1 referred by the Office of the Inspector General (OIG) to the Director, Department of Finance and a copy sent to Comptroller, Joan Pratt, on March 11, 2020.

The OIG reported receiving a complaint related to irregular billing practices by the MTE, the investigation is ongoing. During the investigation, the OIG also reported finding billing concerns that require the immediate attention of the Department of Finance.

On March 2, 2020, the OIG reported discovering a spreadsheet listing Voice Over Internet Protocol (VoIP) lines billed to City agencies but reportedly never installed by MTE (Exhibit 1). According to the OIG, the VoIP spreadsheet was analyzed, and confirmed 240 VoIP lines were never installed, however City agencies were billed for the lines. The OIG report further stated, from September 2017 through February 2020 it was determined that City agencies have reported payments of approximately \$123,543.85 for the 240 VoIP lines that are currently not in service. The OIG reported to have verified the 240 VoIP lines were not in service by calling them directly.

(a) The OIG reported receiving a complaint related to irregular billing practices by the MTE.

As a result of billing irregularities when billing was controlled and managed by Verizon under the Centrex system, an integral part of the implementation of VoIP was the procurement of an effective billing system that could be controlled and managed by the MTE. The MTE procured Win Bill to use as its billing platform. Therefore, MTE billing is more accurate today with VoIP. However, accuracy in billing is dependent upon agency Telecom Coordinators providing timely service requests including requests for changes, adds or moves of telephone equipment. Regular review of the monthly bill as described below is imperative for the agencies.

All City agencies have assigned Telecom Coordinators and budget analysts. The Telecom Coordinators have been provided training on the City's billing platform (Win Bill) which is hosted online. They also have ability to review their departmental monthly bills, and request/pull various reports. The billing system is real- time and agencies can review their bills as far back as to when the system was implemented. The Telecom Coordinators have further been advised that, final monthly bills are only available after the 5th of the month. Occasionally, the MTE receives inquiries on billing questions and these issues are addressed with the responsible agency.

(b) On March 2, 2020, the OIG reported discovering a spreadsheet listing VOIP lines billed to City agencies but never installed by MTE.

Although the OIG said it reported discovering a spreadsheet listing VoIP lines billed to City agencies but not installed, as part of MTE's internal controls we started reviewing traffic on VoIP lines without activity on February 7, 2020. The lines in the OIG's exhibit 1, show a spreadsheet with 20 different City agencies, the bill number, budget number, bill description and charges.

On or about February 7, 2020 a member of the MTE technical staff conducting internal technical controls notified management on findings during a traffic review. The VoIP technical support staff noticed VoIP lines on the network and without traffic activity. The VoIP staff member was directed to conduct a detailed review and determine how many lines are reported inactive. A final report showed 359 inactive lines. Some have been installed for testing over the course of VoIP implementation and are not being billed to any agency. At the direction of Management, the staff brought the findings to the attention of the billing supervisor.

On February 11, 2020, 2:59 PM an email attachment was sent to MTE billing supervisor with 359 lines (Exhibit M-1.) for billing review. The MTE billing supervisor marked each line off and updated the billing system before end of February 2020. At the end of February, billing was suspended for most of these lines pending final technical review and audits with the respective agencies.


According to the OIG's Management Alert, 240 (MTE counted 203) VoIP lines were reported billed to City agencies but never installed. As shown on the process flow for implementing VoIP and billing (Fig.1) below, the first step in VoIP implementation is requirements gathering and analysis. During this step, Mitel engineers meet with each City agency/department to find out their requirements for the new phone system. Based on MTE records 157 lines out 203 on the reported OIG listing were originally installed by Mitel based on agency requirements. The MTE is still in the process of reviewing records to identify the remainder of the 46 lines. It is important to note that once requested services are installed and accepted by the agency Telecom Coordinators, billing is initiated whether the lines are used or not.

The Telecom Coordinators do have a user's group forum (Baltimore Telecommunications Users Group) BTUG, that has been in existence for three years. This user group meets quarterly in the City to discuss telephone issues, new service features and best practices for Telecom Coordinators. One of the paramount best practices is for agencies to request the MTE to move, add or change to telephone equipment or a service. Some agencies have neglected to submit a request to the MTE for moves, adds or changes to telephone equipment and/or to managing their telecommunication monthly bills. It is the responsibility of each City agency to review its monthly telecommunication bills, report any suspected errors or discrepancies in requested services to the MTE, and request an adjustment or credit, if applicable. As discussed below, some of the alleged overbilling resulted from agencies not following documented procedures for services adds/deletes (moves, adds or changes).

Process workflow for implementing VoIP and billing:

The chart below shows the various steps.



(c) Reported physical Audit of OIG's VoIP listing of 203 lines:

MTE technicians were tasked to conduct a random physical audit of some of the lines and offices in the OIG listing. Technicians subsequently found:

- 1. VolP phones packed in boxes (Police department)
- 2. One Comptroller's office VoIP phone was disconnected due to office re-arrangement
- 3. One phone on DPW Director's office alternate desk was moved and not found
- 4. Other agencies had VoIP phones disconnected from the wall jacks.

If properly managed, one of the benefits of VoIP is the ability to move phones to a different location. However, the MTE must be involved through a Telephone Service Request and one of the MTE Techs will move the phone or unplug. Despite official notifications from the MTE advising users not to move their phones because of E911 requirements, some agencies move or unplug phones. Sometimes this occurs after an employee is no longer employed by the agency. The agencies have stated it is their intention to have the

equipment available, when they need a phone in THE future. However, the agency incorrectly assumed that by unplugging a phone the agency would not be billed. Phones/lines programmed in the VoIP system use system resources and licenses for which MTE pays, and for which agencies are billed. Therefore, following established procedures will lessen the likelihood of an agency being billed for service. Telecom Coordinators have been trained on the proper procedures to request, add/remove services. The unintended actions of end users unplugging phones from the network without the purview of the agency Telecom Coordinator raises technical and billing issues.

As part of our internal controls and audit following the OIG's management alert, we further contacted agency Telecom Coordinators with the listing from the OIG and advised them to issue immediate orders to disconnect lines they no longer need. Responses received include one response from the DHCD stating they had several lines in one location which is now occupied by the Health department. A response from DPW advised a conference room phone (410-396-1095) needed by the office of Safety and Training is unplugged, and should not be suspended or disconnected.

(d) Reported Bill Creation Date and Months Billed:

The OIG presented a report showing bill creation date and months billed. The report shows several lines for the Baltimore Police Department (BPD) billed for 28, 26, 18 months. Due to infrastructure and prevailing security issues, the first set of VoIP lines for BPD were installed on 12/17/18 (14 months). It therefore suffices to say, if a number was called and it indicates not in service such as the line at the Comptroller's office which was disconnected from the wall during office changes, it is incorrect to assume the line has been offline since it was installed. Again, simply unplugging a phone does not stop the billing.

(e) The OIG reported verifying lines that were not in service by calling them:

Unlike a traditional plain old telephone (POTS) or analog line from the telephone carrier which often has a recorded intercept to indicate "this line is disconnected or not in service", VoIP calls within the City' internal VoIP network do not have intercepts announcements. A VoIP line is a data line and when called, it will ring continuously if there are multiple rollover lines on the set or it goes to voice mail. Calling a line that has been unplugged will indicate "not in service". It is the responsibility of each agency to provide requirements for phones to be installed. If that phone had been installed but never used (or unplugged) it could be misinterpreted as "never installed". A more reliable test for a VoIP line indicating a "not in service" condition would be to conduct a thorough traffic analysis and intrusive testing. Again, simply unplugging a phone does not stop the billing or use of VoIP system licenses/resource.

Background on VolP Implementation:

The City of Baltimore initiated the Telecommunication Improvement and Procurement project to accomplish several objectives: technical, financial, and operational.

- First, the City needed to modernize its telecommunications systems serving City agencies and the public. It was using proven, but 20th century technology that had been in place for decades with minimal upgrades. The technology supported by Verizon did not provide many of the features, functions, and applications the City needed to address its growing business and Citizens requirements.
- 2. Second, the City aimed to reduce the costs of its telecommunications services. It had been paying monthly recurring costs to Verizon for years for a relatively static and legacy system. In addition, the Verizon billing system was overly complex and cumbersome resulting in frequent monthly billing errors. This complexity necessitated continuous audits for credits back to the City. In addition, the Verizon address database was found flawed with errors of wrong service addresses and quantities.
- 3. Third, the City wanted to decrease its reliance on multiple service vendors that focused on their priorities, rather than those of the City.

The VoIP implementation has resulted in positive impacts on all three of the original objectives. New advanced communication features have been deployed to City agencies and staff. The City has reduced its reliance on communication vendors and is now in more control of critical operational communications infrastructure. City finances along with MTE's budget have been positively impacted with the ongoing VoIP implementation. Overall, billing/physical audits and optimization efforts of Verizon services have continued as increasing number of City agencies are consolidated into the VoIP architecture. As of March 31, 2020, approximately 8649 VoIP lines have been installed across the City enterprise.

Conclusion:

The MTE thanks the OIG for presenting its management alert. We wish to conclude with the following remarks and observations.

- 1. The MTE is in the final stages of a time sensitive VoIP implementation. As an internal service, the MTE is mandated to collect payments from City agencies requesting VoIP or other telecom services to balance its annual budget.
- 2. Occasionally the MTE will make mistakes in billing either through human or computer error, but as soon as the MTE finds the error or is notified by a City agency, the issue is investigated, corrections made and credits applied through journal entries to the respective agency's billing account number.

- 3. MTE will resume billing for the 157 lines that did not bill in February until the respective agency telecom coordinator issues a Telephone Service Request form (TSR) AM 507-1-1 for such line/lines to be permanently disconnected. Based on station programming information provided by Mitel, the 157 lines are valid service requests.
- 4. The MTE recently acquired the Mitel Performance Analytics (MPA) software. The MPA software is an advanced tool that will assist MTE to troubleshoot and proactively monitor VoIP devices, measure network performance, and identify voice and network quality concerns. The MTE VoIP tool will also be available to respond to Telecom Coordinator requests to more quickly answer billing inquiries and confirm service/phone quantities and activities.
- 5. We will revise the administrative manual AM-507-1 (Municipal Telephone Service) and add a section on VoIP policy and online billing management. This will also include reminders to Telecom Coordinators that managing telephone services for their agencies is an active process, rather than a passive role.
- 6. We will continue to remind City agencies to review their monthly bills and offer additional/recurring training on WinBill to new telephone coordinators and budget analysts. We recognize training is a continuum and will ensure our billing team continues to provide administrative assistance to City agencies with any/all billing concerns and questions.

Finally, if the OIG had contacted the MTE before it began its audit process for the lines that were allegedly improperly billed, the internal controls as described above that allowed the MTE to independently identify this billing issue as well as information on its billing process would have been provided to the OIG. This would have resulted in a better understanding of how billing is determined, the proper manner to determine if lines are installed, whether they were billed properly, and therefore should not have resulted in a Management Alert.
